

VENUS BAY COMMUNITY CENTRE



Executive Summary

The Tarwin River has been identified by the community as the most important "asset" of the region and a "gateway to Tarwin Lower, Venus Bay and Walkerville". Community participation in the consultation for this project has been significant and the drive to improve the amenity, function and access to river frontage is of very high important to all.

Tarwin Lower is seen as the local service town, with significant population growth being experienced in the twin town of Venus Bay. Residents from both towns have participated in the project and see the need to ensure a strong connection between the townships, ease of access to shops and local businesses, recreational opportunities and facilities that cater for the growing tourism market.

Essentially the rural farming community relies on the tourism growth to support local business and services. There is concern about empty shops and sustainability of the area, so the community would like to enhance the attraction of the river as well of the livability of the area to help the area to thrive.

Community education about the river health and bank, native vegetation and weed control, ownership and Council service levels have been important parts of the process. There is clear policy and legislative requirement for river protection, infrastructure costs can be restrictive and there are a range of views about what should and can be done that in some instances are in conflict.

This research and consultation report aims to provide a clear and concise summary that the community can utlise as a framework to focus advocacy, volunteering and community education. Local land managers and agencies can refer to this work to better understand the issues impacting on the community, visitors and local business.

There is no doubt that increased maintenance, a range of small scale infrastructure improvements and some longer term management strategies will significantly benefit the district and build a stronger and better connected community.

Methodology & Scope

The following key steps were completed during the development of this research project to ensure effective consultation:

- Funding was received by South Gippsland Shire Council and an independent consultant was appointed to undertake the project.
- A start up meeting was conducted with the project manager and consultant in December 2018.
- A detailed consultation/ stakeholder list was developed as well as advertising to ensure broad community engagement.
- Extensive research, consultation and an industry review were completed.
- A number of site inspections were conducted.
- A presentation at the South Gippsland Shire Community Forum in Tarwin Lower was made followed by a community forum to present the Draft report.
- A draft project report was provided to all stakeholders for review and input.

The project area has been defined in the concept plan and existing conditions. In summary it extends from the boat ramp car park through to the last fishing platform on the Inverloch- Venus Bay Road only along the river side. The project did not include the road area which is managed by VicRoads.

Due to the limited funding available for this project, only concept level plans and engineering advice has been provided. This study has identified a number of areas where further investigation is required.

The Tarwin River precinct is of significant cultural heritage. Detailed research and planning will need to be undertaken prior to any infrastructure projects being undertaken or the development of interpretive signage.

This project was funded by a South Gippsland Shire Community Grant and a broad range of staff have been engaged to provide information to inform this project. This is a community led initiative and will require the ongoing work of a community organisation to advocate for the projects identified in this plan.





Consultation Findings

Prior to the project commencement, a background paper was developed by the Venus Bay Community Centre to outline and inform consultation for the project. A copy of this issues paper can be found in **Appendix 2.**

The detailed list of organisations and individual community members who were consulted during this project can be found in **Appendix 3**.

The summarised findings of all research and consultation has been used to inform all this report while ensuring that individuals are not identifiable.

During consultation for this project, detailed consultation was also being undertaken by South Gippsland Shire Council for the Venus Bay Activity Centre plan and a number of other master plans. Every effort was made to inform the community about the different projects running concurrently and project managers ensured that relevant information for the various projects was shared to the appropriate people.

During consultation for this project, the Tarwin Lower community were working together to advocate for a range of issues in Tarwin Lower, some of these were considered as part of this project as part of the Tarwin River Precinct Plan. However, some of the issues were outside of the scope of this project. Feedback provided during consultation, if outside of the scope was provided back to relevant authorities but not included in this report.

A significant commitment was made to ensure that there was opportunity for the whole community to be involved in this project. In some instances, there was a broad range of opinions provided on the same topic. This report aims to present the range of views and how these align with legislative requirements or future funding opportunities.

It is likely that further consultation will be required to make decisions about some of the issues when the opportunity arises. A good example of this would be the re-location of the tennis courts, there is strong community interest to relocate the courts however not by the tennis facility users. The project would be of significant cost and a future decision will need to be made subject to the funding opportunities available or future use of the tennis courts.





Local Context

Demographic Profile

The official population of South Gippsland 28,936 (ABS estimated resident population). The 5 most populous towns are Leongatha (5,654), Korumburra (4,469), Mirboo North (2,324), Foster (1,842) and Nyora (1,527).

Tarwin Lower

In 2016 there was 358 residents living in Tarwin Lower with a median age of 53. Tarwin Lower's population from 1911 - 2011 jumped up and down a few times but has remained steady between 2011 - 2016. Languages other than English are spoken in 6 households.

15 people in Tarwin Lower reported needing assistance in their day to day lives due to a disability. A smaller proportion of children attended Government Primary Schools than Victoria's average. There are 172 people in the workforce in Tarwin Lower with a higher proportion of people in full time work. There are 248 dwellings with 79 percent of them occupied.



Venus Bay

Venus Bay had a population of 944 at the 2016 census however it has become a popular holiday retreat and this swells into the thousands during holiday periods. In Venus Bay an average of 6 people in each holiday home in peak season has the potential to increase the population to over 7,600 people without accounting for day visitors

The town is split into three 'estates'. The First Estate is home to the only shopping strip in Venus Bay, consisting of a general store, pharmacy, surf shop / hair dresser, cafe, take-away shops, real estate agents, caravan park and a restaurant. Three of Venus Bay's five surf beaches (No. 1, 2 and 3 beaches) are in the First Estate, with the Venus Bay Surf Lifesaving Club located at the No. 1 beach.

The two towns are referred to as "Twin Towns" due to the sharing of infrastructure and services as well as their close proximity. Development of both towns is currently limited as there is no sewage system servicing the area and its introduction is unlikely in the short term due to the development costs.

The area is serviced by one local primary school and a recreation reserve in Tarwin Lower and largely function as small country towns until the peak tourist season. There are very high levels of participation in community volunteering with a very broad range of community facilities, services and groups being managed by volunteer organisations.

Catchment Management

Management of the water way and river system is the responsibility of the West Gippsland Catchment Management Authority.

The West Gippsland Catchment Management Authority (WGCMA) has one of the most diverse natural resource management regions in Australia. It extends from San Remo on the coast in the west to Lakes Entrance in the east and to Mount Howitt high in the Victorian Alps.

The vision statement for the West Gippsland region is:

"Catchment Health - Gippsland's Wealth - The people of Gippsland recognise the importance of our ecosystems, natural resource base, unique natural features and landscapes found within the region. Our inspired, knowledgeable, capable and resilient communities will ensure these continue to underpin the environmental, social, cultural and economic wealth of the region."

The Regional Catchment Strategy takes into account international agreements and key pieces of Australian and Victorian Government legislation including the Catchment and Land Protection Act 1994, Water Act 1989, Planning and Environment Act 1987, Climate Change Act 2010 and Traditional Owner Settlement Act 2010.



The WGCMA recognises that floodplains provide significant social, economic, cultural and environmental benefits to our region. The inherent functions of our floodplains to convey and store floodwater should be recognised and preserved to minimise the deterioration of environmental values and the long-term flood-risk to floodplain production, assets and communities.



Bunurong Coastal Landscape Priority Area

Tarwin Lower is located within the is characterised by estuarine and coastal environments containing extensive intertidal rock platforms and subtidal rocky reefs, which are home to diverse ecological communities. It contains fossil sites of international and national significance and areas of cultural heritage sensitivity. The seagrass and saltmarsh communities found within the landscape priority area provide habitat for migratory waders, resident birds and native fish. The coastal and marine parks and reserves are valued for the recreational opportunities they provide and the threatened species they support.



Projects identified by the community during this consultation need to be considered within the context of the WGCMA strategies and policies as the authority that we need to approve any work related to the river or the adjacent areas.



Issues and Opportunities

This table is a summary of the key themes raised during consultation. These included stakeholder interviews and community consultation.

Rubbish	Household rubbish is being dumped along the riverside, especially from holiday homes. During peak periods the bins are overflowing, smell, rubbish blows into river, and the seal a loop bins on fishing platforms being stuffed with rubbish. There are volunteers managing the Seal a Loop bins and other rubbish collection. The Parks & Gardens team completes routine maintenance and there is a Clean Up Australia Day activity which gets around 6 volunteers. It is a long term problem, more bins needed, more collection needed, fishing lines in river of concern. Rubbish in reeds is hard to clean up.	Council has a Waste Contract in Place and it can be difficult and expensive to vary the contract. Increases in services have been provided which is felt to have made a difference. Weed Removal	Weeds are an issue, unsightly and impact on native vegetation. Re-vegetation/ Trees	Some community members want vegetation removed to improve access and sight lines to river. Implementation

The identified projects as outlined in the previous section have identified a broad range of opportunities that will be most effective if delivered as a partnership between the local community organisations and relevant agencies. The graphic below aims to highlight that the community is central to all projects. There is a need to educate, build capacity, provide support to and engage with the local community organisations and individuals to bring about successful outcomes.



The local agencies will ensure compliance with the legislative and policy requirements, provide funding and resources to assist project implementation. The capacity of these agencies is limited, but with strong community leadership there will be increased likelihood for success.

It is hoped that the consultation for this project will feed into an updated Community Directions Statement for Tarwin Lower – Venus Bay which will further strengthen the support for projects to be implemented. The community will also need to determine the best way to communicate implementation of this plan. This will be discussed at the community workshop and updated to include options.





Recommendations and Conclusions

This report should be referred to as a framework for advocacy and community views as relevant for the development of agency strategies, plans, policies or funding initiatives.

The community can use the plan to bring community organisations together for shared projects and to apply for funding or increased levels of service.

The community need to understand the environmental and cultural values of the site and adopt the plan to "Protect, Preserve and Enhance" the Tarwin River Precinct.

Through implementation of this strategy, there should be improved outcomes for local business through increased visitors and access to the river.

It is recommended that the plan be reviewed by the community in 5 years in 2024.
